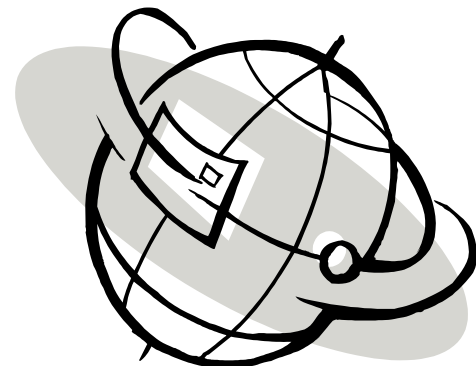


Internationalizing the Internet Addressing System

The Internet has become the main global network which connects our more than two billion internet users worldwide.

Currently, the internet online content language landscape is changing, it's estimated that more than 60% of the Internet contents are in languages other than English, although English language is still widely used by internet users, new languages are being used online now by millions of internet users.

In the Last decade the Internet Technical, Linguist and ICANN Community, has been working on changes to the Domain Names Systems "DNS" in order



to support international languages like Arabic, Cyrillic and Chinese.

The first Internationalized Domain Names "IDNs" were delegated in Internet Root DNS by end of April 2010, more than year after the introduction of Internationalized Domain Names.

One year after the introduction of IDNs, there is more than 33 requests for new IDNs in 22 different languages being made to ICANN.

16 Countries currently have Domain Names in their native language, this change is considered one of the biggest changes in Internet history.

Workshop Objectives

The workshop will present the current status of IDN implementations, sharing best practices and experiences from a group of IDNs Top Level

Domains Operators and identifying the key challenges facing IDN adoption.

The panelists will exchange their countries experiences in

implementing and operating an IDN ccTLD, beside a discussion of the main challenges that might affect the successful adoptions of IDNs.

RAM MOHAN – Moderator
Executive Vice President, & Chief Technology Officer of Afiliis Limited

Ram oversees key strategic, management and technology choices for the company in support of the company's various lines of business. Between 1993 and 1999, Baher served as a Systems Engineer at Egypt's Cabinet Information and Decision Support Center (IDSC), where he participated in establishing the first Internet Point of Presence in Egypt.
